It's an MWR-hosted Trunk-or-Treat Drive-thru for all TRACEN Petaluma families! This is a safe alternative to house trick-or-treating which is not going to be available this year onboard the TRACEN. There are two ways to participate and enjoy this year's Trunk-or-Treat Drive-Thru:

- a. **Distribute Candy:** Distribution of candy will be done from the trunk/tailgate/back of your vehicle. The MWR Office will assign you a spooky parking spot in one of the six designated lots. You are encouraged to decorate your vehicle and your designated parking spot (fog machines, canopies, mummies, scarecrows, etc) and remember, those decorations and costumes must be family friendly for all ages. Please contact the MWR Office with questions. You must submit this form by the deadline to reserve your spooky spot!
- b. **Collect Candy:** Collecting candy will be a little different this year because it will be done from your vehicle following a prescribed route on base to ensure all involved have a safe and enjoyable experience. You are encouraged to decorate your vehicle and for all family members in the vehicle to be in costume! Vehicles will drive the mapped route on page two, stopping at each car to Trunk-or-Treat.


Trunk-or-Treat Drive-Thru Rules

Thank you for signing up for your spooky spot for this year's Trunk-or-Treat Drive-Thru. Please read the following rules and sign below stating you understand and agree to these rules. We look forward to a fun and safe evening!

Rules:

1. Be SAFE!
2. Decorating starts at noon on 31 October.
3. All reserved spooky spots are for one family unit.
4. Do not combine families in one spooky spot.
5. All participants over the age of 2 are required to wear a face covering.
6. You can decorate your face covering or wear a mask over your face covering.
7. All items distributed must be individually wrapped from the manufacturer.*
8. Participants distributing items are required to wear gloves and a face shield which will be provided by the MWR Staff.
9. Change gloves every 15-minutes or each time after touching something that is not disinfected (face, drink, etc).
10. Sanitize hands often and every time gloves are changed.
11. All participants must remain in their designated spooky spot.
12. Clean up your spooky spot after you are done.
13. Please have FUN!

*Candy distribution safety protocols will be communicated after registration and before the event.
